CORPUS FUND:

WHEREAS the AUTHOR of the Trust has set apart a sum of Rs. 5,000 / (Rupees Five Thousand Only) for public charitable purposes and objects of general public utility for the benefit of the public.

NOW THIS INSTRUMENT WITNESSETH AND DECLARES AS FOLLOWS:

1. NAME OF THE TRUST

The name of the Trust shall be " M/s C.K.P MEMORIAL TRUST".

2. OFFICE

The office of the Trust shall be at: 3rt Floor, No. 91, Gomathi Nagar, Ram Nagar North Extension, Inner Ring Road, Velachery, Chennai 600042, Tamil Nadu.

The office of the Trust shall be situated at such place or places as may be decided by the Trustees, from time to time.

3. OBJECTS OF THE TRUST

- i. To establish, to take over or acquire and maintain and manage schools, colleges and other educational institutions, hostels, orphanages, charitable organizations not for profit.
- ii. To identify the physically and mentally handicapped persons and provide them with enough support, so that they will be independent and self-sufficient physically and mentally.
- iii. To give financial or corporal aid or other help to deserving persons.
- iv. To establish, takeover or acquire or maintain and manage creches, homes for the old and disabled and orphanages, and all such other lawful things incidental and conducive to the attainment of the above objects.
- v. To establish, maintain and manage hospitals, laboratories, and Medical Research Centre and to provide the poor with medical aid.
- vi. To give subscriptions or donations to any charitable institutions.

- viii. To take up any rural development program and to conduct the same;

The above two trustees are permanent trustees and can hold their office till their life time unless they resign of their own accord.

3. MANAGEMENT

(i) The Trust shall be managed by a Board of Trustees consisting of minimum two trustees and a maximum of five trustees.

(ii) The Board of trustees shall consist of the following persons:

1. Mr. N Murugan;
2. Mrs. M Kavitha;

(iii) Mr. N Murugan shall be the Managing Trustee for life and he shall be in overall control of the day to day affairs of the Trust.

4. APPOINTMENT AND REMOVAL OF TRUSTEES

(i) Any Trustee may be removed by the Board of Trustees for breach of trust or misconduct.

(ii) Any Trustee desirous of retiring or resigning from the trusteeship shall be entitled to do so after giving one clear calendar months' notice in writing to the remaining trustees.

(iii) In case of any vacancy in the Board of Trustees arising on account of death, retirement, resignation or otherwise of any trustee, the surviving or remaining trustee or trustees as the case may be shall have full powers to constitute and represent the Board of Trustees for the remaining period of the one year Term.

(iv) Any Trustee can voluntarily demit the office of the trusteeship by conveying the same in writing to the Permanent Trustees and such communication shall be placed before the Board of Trustees for information.

(v) The trustees shall in the case of vacancy have the power to co-opt a Trustee or trustees as the case may be to fill up the vacancy or vacancies as the case may be and such trustees/trustee shall hold office for a period of one year which term may be renewed from time to time by the Board of Trustees.

5. POWER OF THE MANAGING TRUSTEE

(i) The managing trustee shall have powers of absolute management of all affairs, activities and business of the trust. The Managing Trustee shall duly carry out all the decisions made by the Board of Trustees.

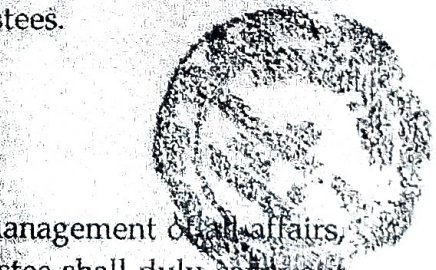

5. POWERS AND DUTIES OF BOARD OF THE TRUSTEES

(a) **BANK ACCOUNT & OPERATIONS:**

- (i) To open one or more bank accounts in the name and for the Trust anywhere in India in the Schedule Banks.
- (ii) The Managing and / or any one of the other Trustees who is nominated by the Board of Trustees shall have the power to operate the same either jointly or severally.

(b) **ADMINISTRATION:**

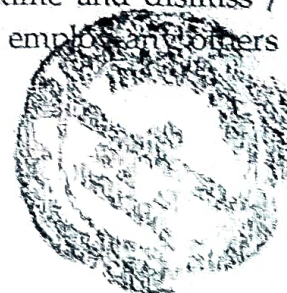
- (i) To do all such acts and things as are necessary for the control and management of the affairs of the Trust and for the purposes of attainment of the objects of the Trust.
- (ii) To execute such power of attorney or attorneys to any person or persons for the purpose of executing and administering the whole or any part of the Trust and by delegation of his power to such Attorney or Attorneys shall only be for the purposes of conventionally, efficiently and advantageously administering the properties of the Trust and for the attainment of the objects of the Trust.
- (iii) To appoint employees / clerks / managers, etc., as may be necessary for the proper management and administration of the Trust as such remuneration / commission or salary as may be proper from time to time and dismiss / discharge such personnel appointed and to appoint and employ others in their places.

(c) **FUNDS:**

- (i) To raise such loan or loans for the benefit of the Trust and shall have the power to sign such Promissory Notes, Bills of Exchange, and any other documents that may be necessary for and on behalf of the Trust.
- (ii) To incur all such expenses as necessary for the execution of the Trust and powers of these present.

(iii) To decide on matters relating to the objects and purposes of the Trust, and to spend the funds of the Trust for those purposes.

(iv) To raise donations and accept gifts or contributions in cash or in kind.

(v) To settle, compromise or compound all and any of the debts, claims, outstanding amounts, disputes, demands, auctions, suits and proceedings whatsoever by or against in any manner relating to the Trust or refer the same to Arbitration.

(d) ASSETS:

(i) To invest funds of the Trust in any movable or immovable properties and further will have the power to sell or vary such investments according to their discretion from time to time.

(ii) However, the pattern of investment should not deviate from the provisions of sec. 13 (i) (d) read with sec. 11(5) of the Income Tax Act, 1961 as applicable from time to time to public charitable institutions.

(iii) To sell, mortgage, lease or create any charges on the whole or any part of the property for attaining the objects of the Trust in their absolute discretion.

(iv) There is no movable (or) immovable properties in the name of the trust at the time of registration.

(e) REMUNERATION OF TRUSTEES:

If the trustees employ themselves in the Charitable Trust as Administrator, they will be paid remuneration according to the market conditions.

(f) RULES & REGULATIONS:

The trust shall be entitled to frame rules and regulations for the better management and administration of the Trust and alter, amend vary such rules and regulations from time to time as they may deem proper. Such rules and regulations shall not be in contravention of the provision of the any act for the time being in force.

6. IRREVOCABILITY:

The TRUST is irrevocable.

7. ACCOUNTS AND AUDIT OF THE TRUST:

- (i) The Official Year of the Trust shall be from 1st April to 31st March of the following year. The first year shall commence from the date of these presents.
- (ii) The Trustees shall maintain proper books of accounts for all the receipts and payments and the accounts of the Trust shall be audited by a Chartered Accountant and the audited statements will be approved by the Trustees.

8. CHARITY LIMITATION:

- (i) The benefits of the Trust will be open to all irrespective of caste, creed, religion or sex.
- (ii) The activities of the Trust would be purely charitable in nature and not motivated for profit. The funds of the Trust shall be applied for the aforesaid objects only within the territories of India.

9. DISSOLUTION:

- (i) If the Trustees decide that no useful purpose will be achieved by the continuation of the Trust, it shall be open to the Trustees to dissolve and wind up the Trust.
- (ii) In the event of dissolution or the winding up of the Trust, the assets remaining as on date of the dissolution should under no circumstances be distributed among the Trustees, but the same shall be transferred to another Trust, Society, Association or Institution named by the Board of the Trustees whose objects are similar to those objects of this Trust and registered under the Income Tax Act under Section 12AA and 80 G.

DECLARATIONS:

- 10. Not more than 5% of the income of the Trust/Institution shall be applied for any religious purpose or given to religious institutions.
- 11. Any alienation of immovable property or any amendments to the Trust shall be done only with the prior approval of the Commissioner / Director of Income Tax (Exemptions).
